

DeSerio Tours Pre-Reservation Allocation Agreement

By making a Tour Selection and paying for a DeSerio Tour Pre-Reservation Allocation on a selected tour, the participant(s) (“You”) are agreeing to the following (the “Agreement”):

1. **Pre-Reservation Allocation Guarantee:** Paying for and agreeing to a Pre-Reservation Allocation on a DeSerio Tour is as follows: You, either a single individual, couple, or family, are collectively agreeing to a non-refundable commitment to reserve space(s) on a DeSerio Tour that has not yet been officially announced/advertised to the public. In return, DeSerio Tours agrees to guarantee space(s) for You on a future tour according to the Tour Selection and year specified on the invoice/receipt. In the event DeSerio Tours cannot offer the Tour Selection originally agreed to at time of Agreement, DeSerio Tours reserves the right to either refund You the amount paid for this Pre-Reservation Allocation, or transfer the Allocation to the next available tour with the same Tour Selection Name/Title.
2. **Tour Selection:** The Tour Selection refers to the Name/Title given by DeSerio Tours for a particular Tour. Tour Selection is made at the time of this Agreement and will be specified by Tour Name/Title on the invoice/receipt paid for this Pre-Reservation. Tour Selection cannot be altered, transferred, credited, or otherwise changed by You once paid for any reason.
3. **Tour Date:** The specific date(s) of the Tour Selection may not yet be known at time of Agreement, but may be within a reasonable timeframe either before or after the month specified on invoice/receipt paid for this Pre-Reservation. The year will also be specified on the invoice/receipt.
4. **Tour Price:** The specific price/cost of the Tour Selection may not yet be known at time of Agreement, however, DeSerio Tours will do its best to maintain a fair pricing across all Tours, reflective of past year-over-year increases in operating costs, inflation, and all other variable expenses relative to the Tour selected. Should You discover the tour price to exceed your expectation, that is not cause for refund, as this Pre-Reservation Allocation is nonrefundable.
5. **Tour Itinerary:** The specific details of the Itinerary for the Tour Selection made are subject to minor change(s), however DeSerio Tours will do its best to maintain an equivalent or superior itinerary to the one referenced and previously advertised under the same Tour Name/Title at time of Agreement.
6. **Tour Sign-Up:** No less than 14 days prior to DeSerio Tours officially releasing the selected Tour to the public, email list, etc. DeSerio Tours will provide “final confirmation information” to You of Tour Date, Tour Price, and Tour Itinerary. You agree to then complete the Sign-Up process for that Tour Selection according to DeSerio Tours, and pay the Deposit Due for that Tour Selection, both within 7 days after receiving final confirmation information. Otherwise if either Sign-Up and/or Deposit have not be complete within 7 days, DeSerio Tours reserves the right to release your guaranteed allocation(s) on the tour You selected, and your Pre-Reservation amount paid and allocation(s) will be forfeited in full.
7. **Cost of Pre-Reservation Allocation:** The price or Cost of Pre-Reservation Allocation is per person and will be specified on the invoice/receipt. The amount paid for this Pre-Reservation will be applied towards the Tour Selection upon official Sign-Up, and the Deposit amount for the tour will then be reduced by the amount paid for this Pre-Reservation per person. If You decide not to Sign-Up for the tour, or wish to cancel your Pre-Reservation Allocation at any time after the Agreement, the amount paid will be forfeited and any space(s) allocated for You on the Tour Selection will be made available to the public.
